I agree to the following:

*To adopt the pet described above, and by doing so, accept the terms of the agreement as set forth below. I/We understand and agree that A Wish for Animals (Known as AWFA. hereinafter) reserves the right to reclaim the pet if any of the following conditions are not met:

*AWFA may repossess the pet if we have reason to believe that the pet is being mistreated, abused (verbally or physically), neglected, or is in an unhealthy condition. I/We further understand and agree that a AWFA representative may make a follow-up visit at a mutually convenient time, to ascertain that all conditions are being satisfied. AWFA's policy is to place animals as family pets. Actions will be filed against anyone adopting an animal for any other purpose.

1. To provide lifetime care (proper food, water, & shelter), including necessary medical care, regular checkups, & vaccinations as necessary.
2. To provide my pet with a collar and a name tag to be worn at all times.
3. The pet shall be leashed when on the public streets, parks, etc., and never transported in the back end of an open truck without proper harnessing.
4. I also agree to notify AWFA if I can no longer provide care for this pet. If for any reason I cannot keep my pet, I agree to return it to AWFA.
5. Failure to spay or neuter by _____ will result in AWFA reclaiming my pet.
5. Dogs sleep indoors and are part of the family. Cats are indoor only. No declawing, allowed on cats.
7. To the best of AWFA's knowledge, unless otherwise specified, my pet is in good health. If health problems arise, I WILL NOT HOLD AWFA LIABLE FOR ANY ADDITIONAL MEDICAL BILLS.
8. If for any reason I/We are unable to keep or provide adequate care for the pet, I/We will contact AWFA. I/We will not sell or give this pet to any other organization, medical laboratory, pound, or animal shelter. _____
